

ORDINANCE NO. 123 N. S.

AN ORDINANCE REPEALING SECTION 4 AND AMENDING SECTION 13 OF ORDINANCE NO. 122 N. S. ENTITLED "AN ORDINANCE OF THE CITY OF EL PASO DE ROBLES IMPOSING A LICENSE TAX FOR THE PRIVILEGE OF SELLING TANGIBLE PERSONAL PROPERTY AT RETAIL, PROVIDING FOR PERMITS TO RETAILERS, PROVIDING FOR THE COLLECTING AND PAYING OF SUCH TAX AND PRESCRIBING PENALTIES FOR VIOLATIONS OF THE PROVISIONS HEREOF."

THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES ORDAIN AS FOLLOWS:

Section 1: That Section 4 of Ordinance No. 122 N. S. of the City of El Paso de Robles passed on the 2nd day of June, 1947, is hereby repealed.

Section 2: Section 13 of Ordinance No. 122 N.S. of the City of El Paso de Robles passed on the 2nd day of June, 1947, is hereby amended to read as follows:

Section 13: DUE DATE. The taxes imposed by this ordinance shall become due and payable to the Tax Collector of the City of El Paso de Robles on or before the last day of the month next succeeding each quarterly period, said quarterly periods being from January 1 to March 31, April 1 to June 30, July 1 to September 30, and October 1 to December 31. The first return and payment to be made on or before the 31st day of October, 1947, for the period commencing with the effective date of this ordinance and ending with and including the 30th of September, 1947.


Section 3: The foregoing ordinance is hereby approved for passage this 21st day of July 1947.


