

ORDINANCE NO. 173 N.S.

AN ORDINANCE AMENDING SECTION II OF ORDINANCE NO. 137  
N. S., AND REPEALING ORDINANCE NO. 161 N. S.

THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES  
DOES ORDAIN AS FOLLOWS:

SECTION I: That Ordinance No. 137 N. S. entitled  
"AN ORDINANCE AMENDING SECTION II OF ORDINANCE NO. 53 N. S.  
AND REPEALING ORDINANCE NO. 117 N. S.", passed and adopted  
on the 7th day of March, 1949, be and the same is hereby  
amended to read as follows:

Section II: The following streets are hereby declared  
to be and constitute boulevards for the purpose of  
this Ordinance, to wit:  
The whole of Spring Street; Oak Street from the  
Northerly line of 13th Street to the Southerly  
line of 15th Street and from the Northerly line  
of 15th Street to the Southerly line of 24th Street;  
Park Street from the Northerly line of 13th Street to  
the Southerly line of 21st Street, and Park Street  
from the Northerly line of 28th Street to the Southerly  
line of 34th Street; Vine Street from the Southerly  
line of 10th Street to the Southerly line of 15th  
Street and from the Northerly line of 15th Street to  
the Southerly line of 24th Street; 12th Street from  
the Easterly line of Pine Street to the Easterly line  
of Spring Street and from the Westerly line of Spring  
Street to the Westerly line of Chestnut Street; 13th  
Street from the Easterly line of Spring Street to the  
Easterly line of Salinas Street; 15th Street from the  
Westerly line of Spring Street to the Westerly line of  
Filbert Street; Olive Street from the Southerly line  
of Pacific Avenue to the Southerly line of 7th Street;  
22nd Street from the Westerly line of Spring Street to

the Easterly line of Vine Street; 17th Street from the Easterly line of Vine Street to the Westerly line of Vine Street; 24th Street from the Westerly line of Spring Street to the Westerly line of Vine Street; 19th Street from the Easterly line of Vine Street to the Westerly line of Spring Street.

SECTION II: That Ordinance No. 161 N. S., entitled "AN ORDINANCE AMENDING SECTION II OF ORDINANCE NO. 137 N. S.," passed and adopted on the 17th day of September, 1951, is hereby repealed.
