

ORDINANCE NO. 183 N. S.

AN ORDINANCE AMENDING ORDINANCE NO. 69 N. S. ENTITLED AN ORDINANCE PROVIDING A SYSTEM FOR THE RAISING OF REVENUE FOR THE CITY OF EL PASO DE ROBLES; AND AMENDING ORDINANCE NO. 74 N. S.

THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: That Section 5 of Ordinance No. 74 N. S. is repealed;

SECTION 2: That the last paragraph of Section 602 of Ordinance No. 69 N. S. is amended to read as follows: "In computing taxes, delinquent penalties, redemption penalties, or interest, fractions of a cent shall be rejected";

SECTION 3: That the title of Section 740 of Ordinance No. 69 N. S. is amended to read as follows: "The First Installment of Taxes is Due November 1";

SECTION 4: That Section 741 of Ordinance No. 69 N. S. is amended to read as follows: "The second installment of taxes is due February 1";

SECTION 5: That Section 753 of Ordinance No. 69 N. S. is amended to read as follows: "All taxes due November 1, if unpaid, are delinquent December 10, at 5:00 o'clock, P. M., and thereafter a delinquent penalty of 6% attaches to them";

SECTION 6: That Section 754 of Ordinance No. 69 N. S. is amended to read as follows: "The second half of taxes on real property, if unpaid, is delinquent April 10, at 5:00 o'clock, P. M., and thereafter a delinquent penalty of 6% attaches to it";

SECTION 7: That Section 755 of Ordinance No. 69 N. S. is amended to read as follows: "If December 10, or April 10, falls on Saturday, the time of delinquency is 5:00 o'clock, P. M., of the next business day.

SECTION 8: That Section 756 of Ordinance No. 69 N. S. is amended to provide that the costs of preparing the Delinquent List is \$1.00 for each assessment on the Secured Roll.


SECTION 9: That paragraph 2 of Section 903 of Ordinance No. 69 N. S. is amended to read as follows:


