

ORDINANCE NO. 186 N.S.

AN ORDINANCE OF THE CITY OF EL PASO DE ROBLES AMENDING  
ORDINANCE #163 N.S.

THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES  
DOES ORDAIN AS FOLLOWS:

SECTION 1: That Section 2 of Ordinance No. 163 N.S.,  
of the City of El Paso de Robles, passed and adopted November 19,  
1951, be and is hereby amended to read as follows:

Section 2: IMPOSITION AND RATE OF TAX. An  
excise tax is hereby imposed on the use or other con-  
sumption in the City of El Paso de Robles of tangible  
personal property purchased from any retailer on or  
after the effective date of this ordinance for use  
or other consumption in said City at a rate of one (1)  
per cent of the sales price of the property. The  
imposition and rate of this tax is hereby effective  
on and after January 2, 1955.


SECTION 2: That Section 26 of Ordinance No. 163 N.S.,  
of the City of El Paso de Robles, passed and adopted November 19,  
1951, be and is hereby amended to read as follows:

Section 26: EFFECTIVE DATE. This ordinance,  
inasmuch as it provides for a tax levy for the usual  
current expenses of the City, shall, under the pro-  
visions of Section 1 of Article IV of the Constitu-  
tion, take effect immediately, provided, however, the  
provisions of Section 2 shall become operative on  
January 2, 1955.


