

ORDINANCE NO. 196 N. S.

AN ORDINANCE AMENDING ORDINANCE NO. 152, N.S.
REGULATING PARKING METERS


THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES ORDAIN AS FOLLOWS:

SECTION I. That Section 2 of Ordinance No. 152, N.S., entitled "An Ordinance Relating to Traffic and Regulations for the Use of Public Streets in the City of El Paso de Robles, Defining and Providing for the Establishment of Parking Meters Zones; Regulating and Controlling and Providing for Inspection of the Parking of Vehicles Therein by the Use of Parking Meters; Prescribing Limits of Time for Parking in Parking Meter Zones; Providing for the Enforcement of This Ordinance and Providing Penalties for the Violation Thereof" passed on the 18th day of December, 1950, is hereby amended to read as follows:


Section 2: The following portions of streets within the City of El Paso de Robles are hereby established as parking meter zones:

- (a) North side of Tenth Street from Park Street to Spring Street.
- (b) South side of Eleventh Street from Park Street to Spring Street.
- (c) Both sides of Twelfth Street from Railroad Street to the Alley immediately East of Vine Street.
- (d) Both sides of Thirteenth Street from Railroad Street to Oak Street.
- (e) Both sides of Fourteenth Street from Pine Street to Spring Street.
- (f) Both sides of Pine Street from Eleventh Street to Fourteenth Street.
- (g) West side of Park Street from Tenth Street to Eleventh Street and both sides of Park Street from Twelfth Street to Fifteenth Street.
- (h) East side of Spring Street from Tenth Street to Eleventh Street and both sides of Spring Street from Twelfth Street to Fifteenth Street.


