

AN ORDINANCE AMENDING THE MUNICIPAL CODE OF THE CITY
OF EL PASO DE ROBLES PERTAINING TO VEHICLES AND TRAFFIC.

THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES ORDAIN AS
FOLLOWS:

SECTION I. That Title 12, Chapter 12.54, Section 12.54.010 of the
Municipal Code of the City of El Paso de Robles be amended to read as follows:

Section 12.54.010 Decrease of state law maximum speed. It is hereby
determined upon the basis of an engineering and traffic investigation that the
speed permitted by state law outside of business and residence districts as
applicable upon the following streets is greater than is reasonable or safe
under the conditions found to exist upon such streets and it is hereby declared
that the prima facie speed limit shall be as herein set forth on those streets
or parts of streets herein designated when signs are erected giving notice
thereof:

(a) Spring Street from the south city limits to the south curb line of
Seventh Street, and from the north city limits to the north curb line of Thir-
tieth Street is hereby determined to be thirty-five miles per hour; and the
speed limit on Spring Street from the south curb line of Seventh Street to the
north curb line of Thirtieth Street is hereby determined to be twenty-five miles
per hour.

(b) Creston Road from the Salinas River Bridge to Golden Hill Road is
hereby determined to be thirty-five miles per hour; and the speed limit on
Creston Road from Golden Hill Road to the south city limits is determined to
be forty-five miles per hour.

(c) Riverside Avenue from the south line of Thirteenth Street to the
south Freeway off-ramp is hereby determined to be thirty-five miles per hour;
and the speed limit on Riverside Avenue from the north line of Thirteenth
Street to the north city limits is hereby determined to be twenty-five miles
per hour.

(d) Miblick Road from the westerly boundary of Tract No. 147 to Creston
Road is hereby determined to be twenty-five miles per hour.

(e) South River Road from Creston Road to south city limits is hereby
determined to be twenty-five miles per hour.

(f) Pacific Avenue from west city limits to Olive Street is hereby de-
termined to be twenty-five miles per hour.

(g) Twenty-fourth Street from west city limits to the 101 Freeway is hereby determined to be twenty-five miles per hour.

SECTION II. That Title 12, Chapter 12.90, Section 12.90.040 of the Municipal Code of the City of El Paso de Robles be amended to read as follows:

Section 12.90.040 Angle Parking on certain streets. In accordance with Section 12.32.080 (C) and when signs or markings are in place giving notice thereof, drivers of vehicles may stand or park a vehicle only as indicated by such marks or signs on the following streets or portions thereof:

(a) Tenth Street, on the south side only, between Park Street and the alley one hundred fifty feet easterly from Park Street.

(b) Eleventh Street, on both sides, between Pine Street and Spring Street.

(c) Twelfth Street, on both sides, between Railroad Street and Spring Street; and south side only between Spring Street and Vine Street.

(d) Thirteenth Street, on north side only, between Oak Street and Vine Street.

(e) Fourteenth Street, on both sides, between Railroad Street and Park Street; and north side only between Park Street and Spring Street; and south side only between Spring Street and Vine Street.

(f) Pine Street, on both sides, between Eleventh Street and Fourteenth Street.

(g) Park Street, on both sides, between Ninth Street and Tenth Street; and on both sides between Twelfth Street and Fifteenth Street.

(h) Oak Street, west side only, between Thirteenth Street and Fourteenth Street.


