

ORDINANCE NO. 425 N.S.AN ORDINANCE AMENDING ZONING MAP ESTABLISHED BY
REFERENCE IN SECTION NO. 21.12.020 OF THE
MUNICIPAL CODE OF THE CITY OF EL PASO DE ROBLES

The City Council of the City of El Paso de Robles does ordain
as follows:

SECTION I. That the Zoning Map of the City of El Paso de Robles
dated August 3, 1959 shall be changed or amended as follows:

- A. That Section 21.21.020, MAP ALTERATIONS, be changed by
providing that the following described property be changed
from R-1 designation to R-2a designation:

The northerly 150 feet of Lots 9, 10 and
11 of Block 196.

- B. That Section 21.21.020, MAP ALTERATIONS, be changed by
adding thereto the following described property on
prezoning said property as R-1 (B-3) zone:

A portion of Villa Lot 84 (Deer Park) also
known as Annexation No. 35 (Taylor Annexation)
to the City of El Paso de Robles.

SECTION II. That the Zoning Map of the City of El Paso de Robles
dated May 9, 1977 shall be amended or changed as follows:

- A. That Section 21.21.020, MAP ALTERATIONS, be changed by
providing that the following described property be rezoned
from R-1 to R-1-PD designation:

A portion of Lots 19 and 20 of Olive Park
Tract (AP# 09-561-38 and Tract 619).

- B. That Section 21.21.020, MAP ALTERATIONS, be changed by
providing that the following described property be rezoned
from R-3 to R-3-0 designation:

Lots 51 and 52 of Associated Almond Growers
Orchard Bungalow Tract.
