

ORDINANCE NO. 468 N.S.

AN ORDINANCE AMENDING THE MUNICIPAL CODE OF THE CITY OF
EL PASO DE ROBLES PERTAINING TO VEHICLES AND TRAFFIC

The City Council of the City of El Paso de Robles does ordain as follows:

SECTION 1. That Title 12, Chapter 12.54, Section 12.54.010 of the Municipal Code of the City of El Paso de Robles be amended to read as follows:

Section 12.54.010 Decrease of state law maximum speed. It is hereby determined upon the basis of an engineering and traffic investigation that the speed permitted by state law outside of business and residence districts as applicable upon the following streets is greater than is reasonable or safe under the conditions found to exist upon such streets and it is hereby declared that the prima facie speed limit shall be as herein set forth on those streets or parts of streets herein designated when signs are erected giving notice thereof:

(a) Charolais Road from Creston Road to west City limits, forty five miles per hour;

(b) Creston Road from the easterly end of the 13th Street Bridge to the westerly curb line of Trigo Lane, thirty five miles per hour;

Creston Road from the northerly curb line of Niblick Road to the westerly curb line of Golden Hill Road, forty miles per hour;

(c) Niblick Road from Creston Road to the westerly curb line of Appaloosa Drive, forty miles per hour;

(d) Paso Robles Street from the southerly City limits to the southerly curb line of 13th Street, forty miles per hour;

(e) Riverside Avenue from the southerly curb line of 13th Street to the southerly City limits, forty miles per hour;

Riverside Avenue from the northerly curb line of 13th Street to the southerly curb line of 24th Street, thirty five miles per hour;

Riverside Avenue from the southerly curb line of 24th Street to north City limits, forth miles per hour;

(f) Scott Street from Creston Road to the westerly curb line of Westfield Road, forty miles per hour;

(g) South River Road from the southerly curb line of Creston Road to the northerly curb line of Niblick Road, thirty five miles per hour;

(h) Sherwood Road from the easterly curb line of Creston Road to Fontana Road, forty five miles per hour;

(i) Spring Street from the northerly City limits to southerly curb line of 24th Street, thirty five miles per hour;

Spring Street from southerly curb line of 24th Street to southerly curb line of 15th Street, thirty miles per hour,

Spring Street from southerly curb line of 15th Street to southerly curb line of 10th Street, twenty five miles per hour;

Spring Street from southerly curb line of 10th Street to southerly City limit, thirty five miles per hour;

(j) 24th Street from the westerly City limit to the westerly curb line of Park Street, thirty five miles per hour;

24th Street from the westerly curb line of Park Street to State Highway 101, thirty miles per hour;

- (k) Vine Street from the southerly City limits to the southerly curb line of 24th Street, thirty miles per hour;

Vine Street from the northerly curb line of 24th Street to the northerly curb line of 32nd Street, thirty miler per hour.

IN ADDITION to be above, the City Council has hereby determiend that the following streets or parts of streets shall have the following speed limits:

- (a) Creston Road from Meadowlark Road to Niblick Road, forty miles per hour;
Creston Road from Golden Hill Road to Trigo Lane, thirty five miles per hour;
- (b) Golden Hill Road from Creston Road to City limits, thirty five miles per hour
- (c) Niblick Road from South River Road to the westerly curb line of Appaloosa Drive, forty miles per hour;
- (d) Pacific Avenue from the westerly City limits to Olive Street, thirty five miles per hour;
- (e) Paso Robles Boulevard from North River Road to the northeasterly City limit on Paso Robles Boulevard, thirty five miles per hour;
- (f) North River Road from Creston Road to the northerly city limits, forty miles per hour.
