

ORDINANCE NO. 707 N.S.

AN ORDINANCE OF THE CITY OF EL PASO DE ROBLES
 AMENDING ORDINANCE 613NS (SIGNS) OF THE ZONING CODE
 TO EXPAND THE GEOGRAPHIC DISTRICT WHERE HIGHWAY ORIENTED SIGNS
 MAY BE CONSIDERED FOR APPROVAL THROUGH CONDITIONAL USE PERMIT

WHEREAS, at its meeting of January 8, 1996, and January 22, 1996, the Planning Commission took the following actions regarding this ordinance:

- a. Considered the facts and analysis, as presented in the staff report prepared for this project;
- b. Conducted a public hearing to obtain public testimony on the proposed ordinance;
- c. In accordance with the California Environmental Quality Act, considered a proposed Negative Declaration, and made a recommendation that the City Council adopt a Negative Declaration; and
- d. Recommended that the City Council adopt an ordinance amending the Sign Ordinance to expand the highway sign district, and

WHEREAS, at its meeting of February 6, 1996, the City Council held a public hearing and took the following actions regarding this ordinance:

- a. Considered the facts and analysis, as presented in the staff reports prepared for this project;
- b. Conducted a public hearing to obtain public testimony on the proposed ordinance;
- c. Based on the scope and nature of the proposed code change, found that the proposed ordinance would not have a significant effect on the environment and adopted a Negative Declaration in accordance with the California Environmental Quality Act; and
- d. Considered the Commission's recommendation from their January 8, 1996 and January 22, 1996 public meetings; and
- e. Introduced said ordinance for first reading, and

WHEREAS, on February 20, 1996 the City Council held second reading of said ordinance.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of El Paso de Robles, California to adopt this ordinance to amend the zoning code regulations for Signs adopted by Ordinance 613N.S. by amending Figure 21-19-1 as indicated in the attached exhibit "A" to this ordinance.


