*Suspects Sought*

PASO ROBLES, CA – The Paso Robles Police Department is requesting public assistance with locating Janet Marie Deras (04-27-1996) and Ines Marie Jimenez (09-15-1987). Investigators suspect the two women are passing fraudulent \$100 bills at businesses throughout the central coast.

The women attempted to pass (2) fraudulent \$100 bills at the J.C. Penny department store in Paso Robles on January 31, 2018. The women were possibly accompanied by Joshua Lee Maddox (02-15-1980, no picture available), another person of interest. Maddox is possibly associated with a yellow 2018 Chevrolet Camaro.

Janet Marie Deras CAL # F7324380 (Above left) attempted to pass 2 fraudulent 100 dollar bills at the JC Penny Dept store in Paso Robles on 01-31-2018, case # 18-0327. Deras was positively identified by photo line up. She and Ines Marie Jimenez CAL # D8589835, are being investigated for a series of similar crimes along the central coast. When contacted they act as though they had no idea the money was fraudulent. They may be associated with Joshua Lee Maddox who was last contacted driving a yellow 2018 Chevy Camaro.

Both females have numerous tattoos on their chests just below the neckline. They often wear shirts showing the tattoos. Deras has 2 star tattoos over her left eye and a V shaped diamond pattern tattoo in the center of her chest.
