The City has returned to virtual public meetings as allowed by the AB 361, which allows for a deviation of teleconference rules required by the Ralph M. Brown Act. The meeting will be virtual because state and local officials are recommending measures to promote social distancing. Senior Citizen Advisory Committee meetings will be held virtually only until further notice.

Rather than attending in person, residents have three options:
