#### DISCUSSION

#### 1. Library Board of Trustees

The Library Board of Trustees advocates for continued and increased community support for the programs and services offered by the Paso Robles City Library.

The City Council appointed for one vacancy and waived the interview as the applicant was an incumbent committee member.

#### ROLL CALL VOTE

Motioned by Councilmember Hamon, seconded by Councilmember Gregory and passed unanimously to appoint Michael Miller to an additional term on the Parks & Recreation Advisory Commission.

#### 2. Parks & Recreation Advisory Committee

The Parks and Recreation Advisory Committee provides a communication link between the community, City Council and the staff of the Community Services Department as the City strives towards a better quality of life for its citizens. The Committee is advisory in all matters pertaining to parks, recreation, playground, and entertainment.

The City Council appointed for three vacancies, waiving the interview for the two incumbents, Dale Breckow and Gennaro Messina, and held the interview for Rich Clayton, the new applicant.

- Dale Breckow - Incumbent committee member – no interview required
- Gennaro Messina - Incumbent committee member – no interview required
- Rich Clayton – new applicant

#### ROLL CALL VOTE

Motioned by Councilmember Gregory, seconded by Councilmember Garcia, and passed unanimously to appoint Dale Breckow, Gennaro Messina, and Rich Clayton to the Parks & Recreation Advisory Committee.

**3. Senior Citizen Advisory Committee**

The Senior Citizen Advisory Committee represents the senior citizens of the community on issues and matters related to the senior center and its attendant recreation programs. It is responsible for researching and advising the City on the needs of senior citizens, making recommendations regarding Senior Endowment Fund and annual Senior Center expenditures, and is a communication liaison to the senior citizens of Paso Robles.

The meeting agenda originally stated that the City Council was appointing for one vacancy, however, there were two vacancies as noted by City staff as the item was being presented. The City Council waived the interview for the incumbent, Becky Hallett, and held the interview for Harvest Steadman, the new applicant.

- Becky Hallett – incumbent committee member – no interview required
- Harvest Steadman – new applicant
